Another successful Year for the Joint Council And Fire Caucus

The Fourth Annual Utah Fire Caucus Luncheon at the Utah Capitol on February 4, 2008, drew about 50 legislators who passed out awards, enjoyed a nice lunch and talked about Utah’s fire service. Firefighters came to Salt Lake City from all over the State for the opportunity to visit with their legislators.



Co-chairs for 2008 are Sen. Curtis Bramble, Sen. Patricia Jones, Rep. Brad King and new co-chair, Rep. Todd E. Kiser.

Joint Council of Fire Service Organizations Chair Frank Heumann asked that the group observe a moment of silence for Utah firefighters who have lost their lives in the line of duty, including the late Sen. Ed Mayne, who is considered an honorary Utah firefighter. Rep. Kiser recognized Rep. David Clark for his service as Fire Caucus Co-chair from 2004 to 2007.

Senator Jones presented the Distinguished Service Award to Millard County fire officers and firefighters for their outstanding efforts to protect life and property in Central Utah's massive Milford Flat fire last summer. Delta Fire Department firefighters Rick Bublitz, Bruce Curtis and Jared Rawlinson accepted the award on behalf of their crews.



The Utah Fire Caucus is a non-partisan organization that is modeled after the Congressional Fire Services Caucus (CFSC). It receives support from Utah's Joint Council and, like the CFSC, Utah Fire Caucus members are not required to take specific positions on legislation. Rather, they are asked to pledge support in a way



that best benefits fire departments within their respective legislative districts.

PEHP Update for Retirees Under 65 Years Old

Led by Jodi Langford of SLC Corp Human Resources, the Salt Lake City Benefits Committee concluded their yearly evaluation of Salt Lake City's insurance program and made recommendations for next year.

All rate and benefit changes proposed by the committee are only recommendations and may or may not be adopted by the Mayor and City Council. The more important proposals from the committee include:

- Summit plan will be changed from Altius to the WISE Provider Network

- A 14 percent increase in premiums
- No change in deductibles for any of the three plans
- Implementing a wellness program that offers incentives for plan members who work to improve health risk factors

While this is not good news for retirees, believe it or not it could be worse. Salt Lake City is certainly not alone in dealing with double digit rate increases. Each year the discussion centers on the same subject—how to reduce costs. Somebody has to pay for it. Remember, the above are

just recommendations until acted on by the Mayor and City Council.

The decision to change the Summit Plan from Altius to WISE on July 1 was made because the contract with Altius ends in June, so PEHP had to put out a request for proposal to lease a network. Jodi Langford served on the Committee as the representative for the City along with other employer representatives. The committee voted to contract with WISE for their network. There were many reasons, including cost savings and numerous communication problems between PEHP and Altius. Anyone staying on the Summit Plan will need to check the provider list, but there are surprisingly few providers on the Altius list who are not on the WISE list. Jodi reports that WISE is very open to adding new providers, and that they will pursue adding providers that plan members want. WISE is a non-IHC provider network located in Utah and Wyoming, and includes

about 6,000 providers and 39 hospitals in Utah.

The prescription benefit for the Summit Plan will again be handled by Medco rather than Caremark. To reduce the problems for those who have current mail order prescriptions, PEHP is now working to transfer the information from Caremark to Medco.

All the above only applies to those retirees under age 65 who are insured by Salt Lake City's PEHP Preferred, Advantage or Summit plans.

Members of the Benefits Committee include representatives from Salt Lake City employee groups, city departments and PEHP. Jodi Langford serves as the head of the committee and facilitates the flow of information. Ray Schelble and Mark Brim represent retirees on the committee.
